Beginning in late August, Bridge will be sending out EMV enabled credit cards. All new cards will be reissued for you. This added security will help to prevent fraud and keep your finances safer.

What does this mean for you?

- Your new card will start working on 09/11/2017.
- Your rate will stay the same.
- If you have a cashback card, you will see no change.
- If you have a rewards card, your Scorecard points will transfer to our new program, Asio (more details will be provided at a later date).
- You will need to update your card number with any online accounts or recurring payments (Ex: Amazon, gym memberships, app stores, etc.)
